

# Chamber's Future 50 Honors Entrepreneurial Success

Having received more than 180 nominations, the Nashville Area Chamber of Commerce has announced the winners of the 2005 Music City Future 50 awards.

Now in its 14th year, the Music City Future 50 identifies and recognizes the 50 fastest-growing privately held companies in Middle Tennessee.

KraftCPAs, the official accounting firm of the Music City Future 50, tabulated the nomination forms. Qualifying companies are privately owned and headquartered in Middle Tennessee. Applicants are scored based on questions relating to past and future employment and revenue growth.

"Our Future 50 companies exemplify the strength of Middle Tennessee's economy," said Chamber small business vice chair Lucy

More than half of this year's Future 50 companies are repeat winners. In addition, one company, Brentwood-based Infrastructure Corporation of America, has been inducted into the Future 50 Hall of Fame, reserved for companies that have won five times.

The 2005 Future 50 winners employ approximately 3,064 with an average of 61 employees per company, and bring in an estimated annual revenue of \$900 million, with an average of \$18 million per company.

The winning companies, which are listed on their right, will be honored Thursday, Sept. 29, with an awards dinner at the Franklin Marriott Cool Springs. ## BREI Honors Chamber's Business Retention and Expansion Program

The Nashville Area Chamber of Commerce was recognized for its "innovative, effective and exemplary" business retention and expansion program by Business Retention and Expansion International (BREI) at the BREI annual conference in June.

The Tennessee Valley Authority nominated the Nashville Area Chamber for the development of its "Workforce Health" report for the Nashville-Murfreesboro Metropolitan Statistical Area. Using data

gathered from interviews with 83 primary sector manufacturers, the Chamber discovered opportunities for the creation of more than 770 jobs and more than \$63 million in capital investment for the area.
